

Oman Visas - Identify your visa type

Visa-free Entry

We are pleased to inform you that citizens of 100 countries enjoy visa-free entry to the Sultanate of Oman for a period of 14 days. This means that travellers holding passports from these countries, subject to certain conditions for some of those countries, can enter Oman without the need for a visa. Whether you are visiting for business, tourism, or other purposes, Oman warmly welcomes you with open arms.

Please note that the 100 countries are separated into two groups:

1. First Group
2. Second Group

The **First Group** of countries are listed below:

The countries listed under the first group can enter Oman without a pre-arranged visa for a maximum stay of 14 days but need to comply with the below conditions.

Conditions for entering the Sultanate of Oman without a Visa. (First Group)

- The visitor must hold a passport valid for no less than (2) months.
- They must have a return ticket, a confirmed hotel reservation, health insurance, and a sum of money that will enable him to bear the burden of living during his stay in the Sultanate.
- The person will be allowed to stay in the Sultanate for a period of (14) days, which cannot be extended or transferred to any type of residence visa.

The Second Group of countries are listed below:

The countries listed under the Second Group can enter Oman without a pre-arranged visa for a maximum stay of 14 days if they can meet the conditions outlined below.

Conditions for entering the Sultanate of Oman without a Visa. (Second Group)

- The visitor must hold a passport valid for no less than (2) months.
- They must have a return ticket, a confirmed hotel reservation, health insurance, and a sum of money that will enable him to bear the burden of living during his stay in the Sultanate.
- To obtain this facility, citizens of the second list countries are required to be **either residents or have a valid entry visa for one of the following countries (the United States of America, Canada, Australia, the United Kingdom, Schengen Agreement countries, Japan), or to be residents of one of the countries The Gulf Cooperation Council and its profession are among the professions that benefit from the resident visa.**
- The person will be allowed to stay in the Sultanate for a period of (14) days, which cannot be extended or transferred to any type of residence visa.
- The husband, wife, and children benefit from this facility, even if they are not nationals of the country.

For all those people in the Group List of Countries who cannot comply with the above conditions, they can still apply for an “Unponsored Tourist Visa” directly

on the [Oman Visa Portal](#) or for added reassurance Khimji House of Travel can arrange a “Sponsored Tourist Visa”.

Sponsored Tourist Visa

Khimji's House of Travel can pre-arrange Sponsored Tourist Visas for certain nationalities including the citizens of 100 countries listed on the above link. Please note that tourist visas are valid for single entry only and the services are chargeable.

Tourist Visa

- Short stay visa (10 days validity)
- Long stay visa (30 days validity)

Documents required

- Scanned colour copy of passport (photo page and address page) with a minimum 180-day validity as on the date of arrival in Oman (jpeg or pdf format with a file size not exceeding 500kb)
- Recent passport size photograph in white or light blue background (png or jpeg format with a file size not exceeding 500kb)
- Copy of return flight tickets (pdf or word format with a file size not exceeding 500kb)

Terms & conditions

- Visa application charges are non-refundable.
- Visa approval is purely subject to the discretion of the immigration authorities.
- Visa processing time is approximately three official working days in Oman (Sundays-Thursdays).

Express visa (21 days validity)

Khimji's House of Travel can pre-arrange Sponsored Express visas for the countries that are not included in the list of 100 countries. Please note that visas are valid for single entry only and the services are chargeable. RCOG has been advised that this is the most reliable way to obtain a visa for those countries not within the 100 country lists.

Documents required

- Scanned color copy of passport (photo page and address page) with a minimum 180-day validity as on the date of arrival in Oman (jpeg or pdf format with a file size not exceeding 500kb)

- Recent passport size photograph in white or light blue background (png or jpeg format with a file size not exceeding 500kb)
- Copy of return flight tickets (pdf or word format with a file size not exceeding 500kb)
- Proof of accommodation (pdf or word format with a file size not exceeding 500kb)
- RCOG official invitation (mentioning the name of the applicants with their passport numbers and purpose of visit - event details with event location and dates).
- **Visa application can only be submitted within 30 days to the date of arrival in Oman however we advise you to collate your application and supporting documents and send to Khimji's House of Travel in advance and they will submit the application as soon as the 30-day limit applies.**
- Visa must be utilised before 30 days from the date of issue

- Visa application charges are non-refundable.
- Visa approval is purely subject to the discretion of the immigration authorities.

Visa processing time is approximately three official working days in Oman (Sundays-Thursdays).
